The user must login into their EmaraTax account and open the respective Corporate Tax tile, to initiate the application.

	What's next?
i	 Once the application is submitted, the FTA shall approve, reject and notify the Taxable Person accordingly. If the FTA requires any further details from you in order to assist with the verification of your application, you will receive an email notification setting out the information required from you. Once the FTA confirms acceptance of your application, you will be notified on the decision. The status of your application in the dashboard will be updated accordingly. You may check your application status in the dashboard from time to time.

- Application submission acknowledgment.
- Additional information notification (only if the FTA requires more information to assist with their review of your application).
- Application approval or rejection notification.
