-A A +A	This is used to decrease, reset, and increase the screen resolution of the user interface of the portal

Introduction

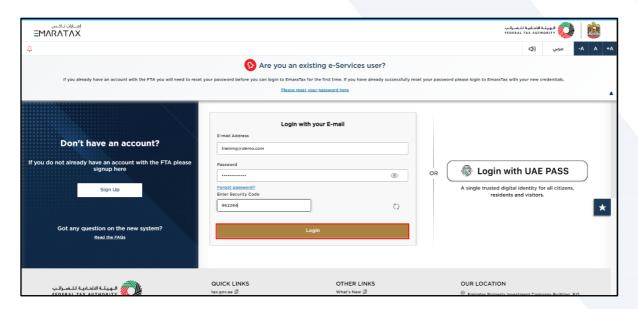
This manual is prepared to help a Corporate Tax registered Taxpayer to navigate through the Federal Tax Authority EmaraTax portal and submit their Corporate Tax De-Registration application. A Taxpayer is eligible to apply to the FTA for De-registration from Corporate Tax based on the following criteria:

- Cessation of Business
- Sale of Business
- Merger of Business
- Redomiciliation of Business
- Any other reasons for Corporate Tax purposes





Login to EmaraTax



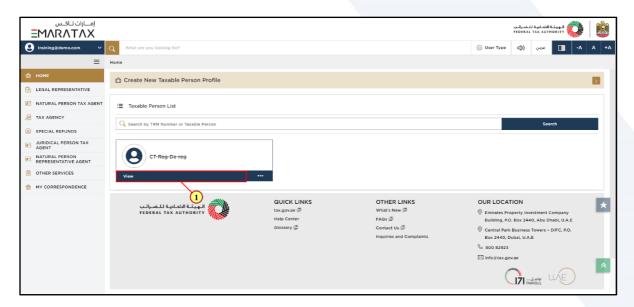


You can login into the EmaraTax account using your login credentials or using UAE Pass. If you do not have an EmaraTax account, you can sign-up for an account by clicking the 'Sign Up' button. If you have forgotten your password, you can use the 'Forgot password?' feature to reset your password.





Taxable Person Tile

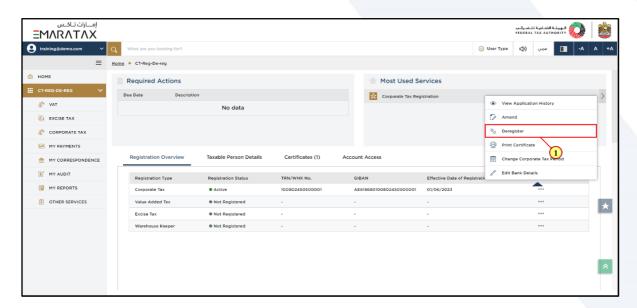


Step	Action

Corporate Tax De-Registration

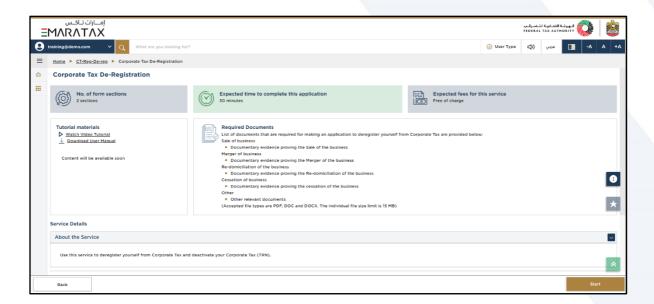


Step	Action
(1)	 In order to deregister from your Corporate Tax Registration application, click '' against the registered Corporate Tax application. Select 'Deregister' to start deregistration of your Corporate Tax Registration application.





Instructions and Guidelines

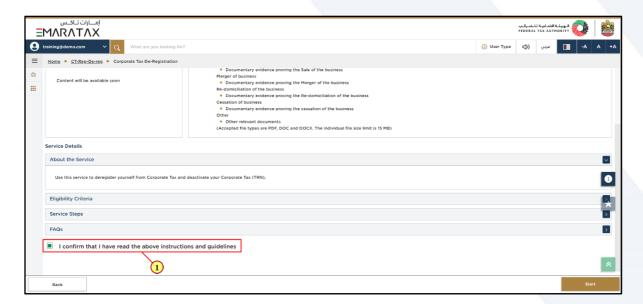

De-Registration Details Section



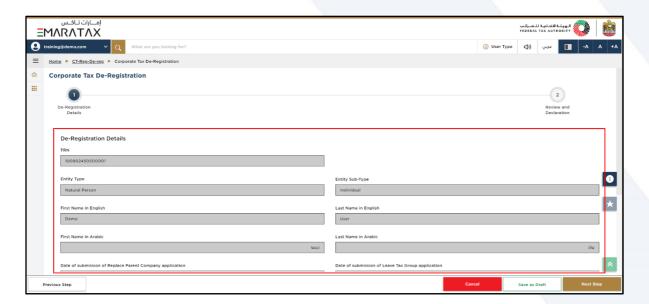




- In order to move from one section to the next, all mandatory fields of the current section
 must be entered. The fields which are optional are marked as optional next to the field
 name.
- You are requested to ensure that the documents submitted, supports the information entered by you in the application. This would help to avoid any rejection or resubmission of the application later.
- The Taxpayer cannot make amend in Deregistration Details section within the CT De-Registration application. To update any details, the Taxpayer must use the Amend Taxable Person Details Application instead.





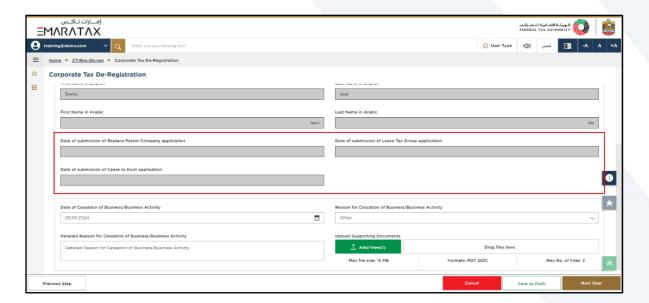




The Applicant Details section is pre-populated with your Entity details from your Registration application. You cannot make amends to this section.





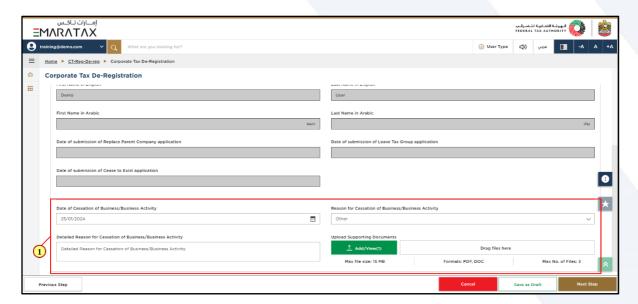




Date of submission of other applications, if any, will be pre-populated here. You cannot make amends to this section.



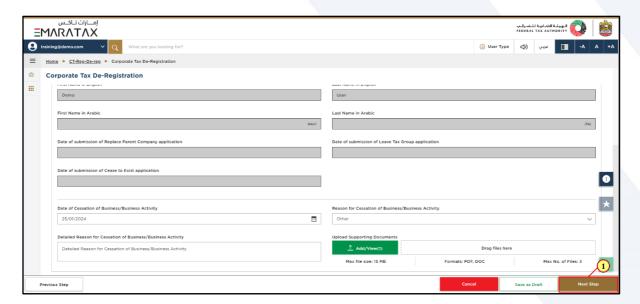




Step	Action
(1)	 Enter details related to Cessation of Business/Business Activity. Upload supporting documents.





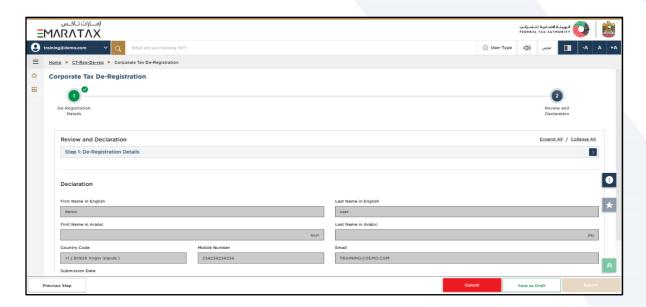


Step	Action

Review and Declaration

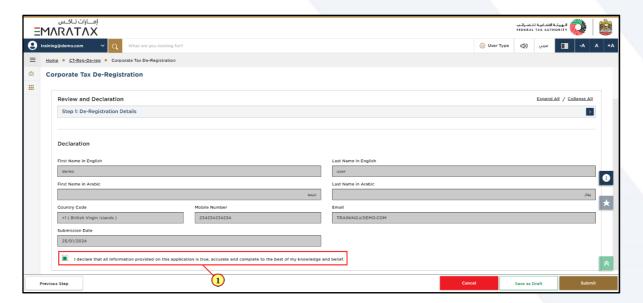




This section highlights all the details entered by you across the application. You are required to review and submit the application.



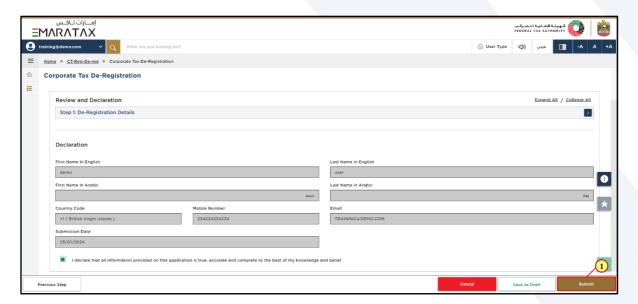




Step	Action
(1)	After carefully reviewing all of the information entered on the application, mark the checkbox to declare the correctness of the information provided in the application.



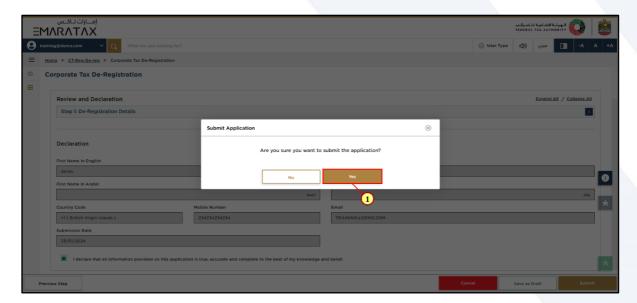

Ī	(1)	Click 'Submit' to submit the Corporate Tax De-Registration application.





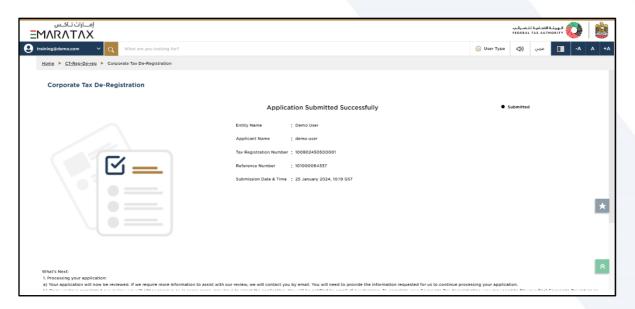


Step	Action

Post Application Submission



After your application is submitted successfully, a Reference Number is generated for your submitted application. Note this reference number for future communication with the FTA.

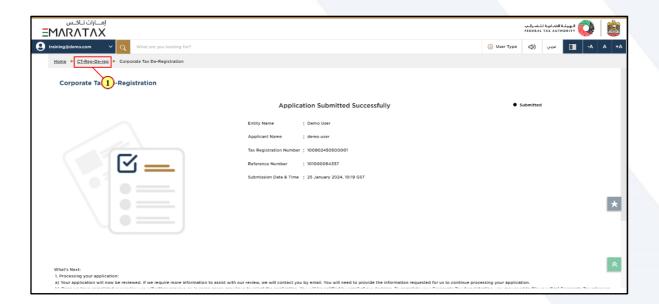
What's next?



- Once the application is submitted, the FTA shall approve, reject or resubmit for additional information and notify the applicant accordingly.
- If the FTA requires any further details from you in order to assist with the verification of your application, you will receive an email notification setting out the information required from you.
- Once the FTA confirms acceptance of your application, you will be notified on the decision.
- FTA might request a final return. FTA will take time to review the return.
- The FTA will not proceed with the De-Registration application if the Taxpayer has other
 pending applications (example, Change in Tax Period application). Additionally, the DeRegistration request will not be approved unless the Taxpayer has settled all outstanding
 tax liabilities.
- The status of your application in the dashboard will be updated accordingly. You may check your application status in the dashboard from time to time.







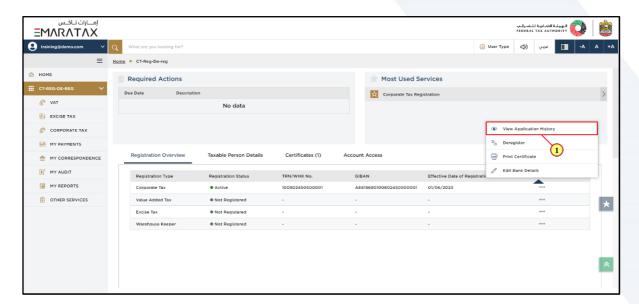
Step	Action
(1)	Click on the taxable person name to navigate back to Taxable Person dashboard.





Application History - In-Review

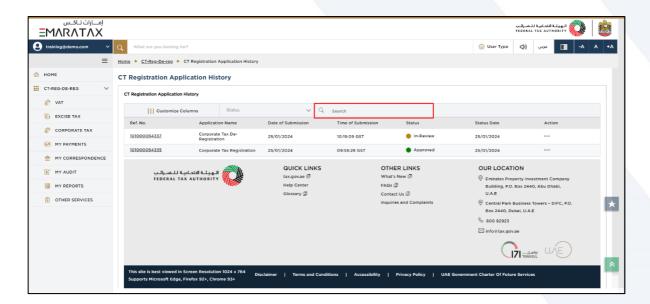
Once the Taxpayer submits the application for De-Registration, the application will be sent to the FTA for review and the status of the application will be 'In-Review'.



Step	Action
(1)	 In order to view the application status, click '' against the registered Corporate Tax application. Select 'View Application History' to view the status of your application.





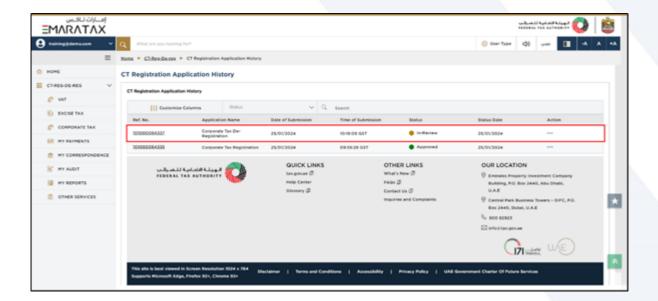




You can search for your application from 'Search' function in the applications history.









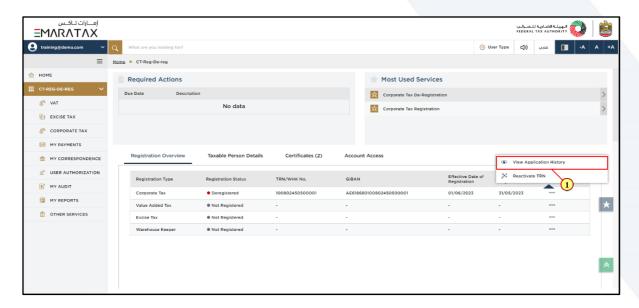
- You can check the status of the application based on the application number once the application has been submitted.
- Taxpayer cannot edit or cancel the application while it's in review with FTA.





Application History – Approved

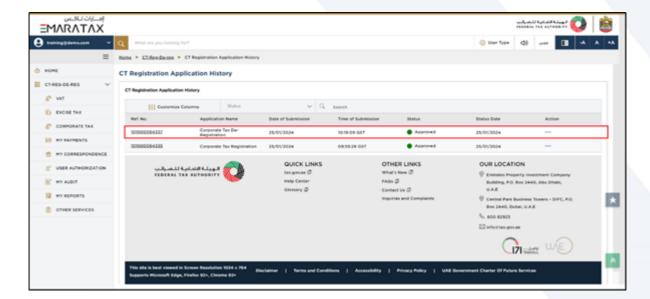
Once the FTA approves the application for De-Registration, the process is complete and the status of the application will be 'Approved'. The Registration status will be 'Deregistered' and the De-Registration Certificate will be issued.



Step	Action
(1)	 In order to view the application status, click '' against your Deregistered Corporate Tax application. Select 'View Application History' to view the status of your application.







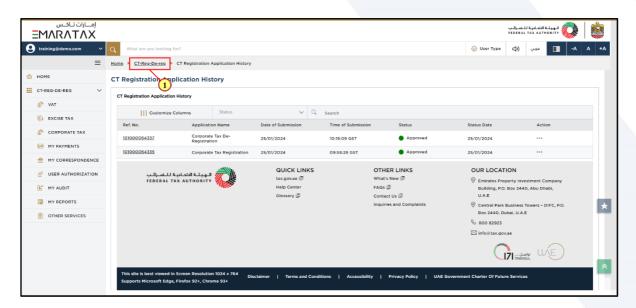


You can check the status of the application based on the application number once the application has been approved.





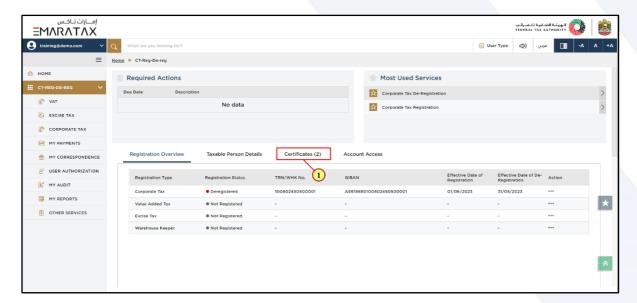
Certificates

(1)	Click on the Taxable person name to navigate back to view the De-Registration Certificate.



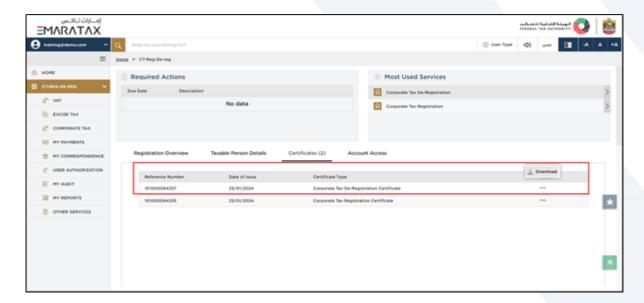




Step	Action
(1)	Click 'Certificates'.





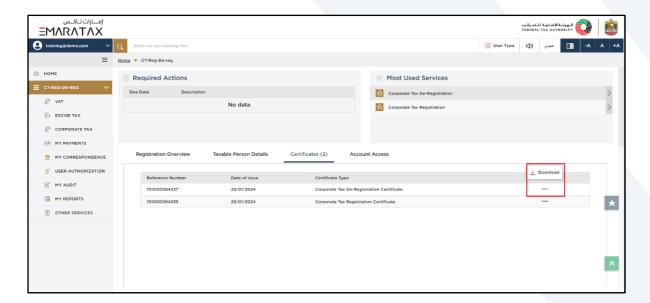




You can find your Corporate Tax De-Registration Certificate here.

Correspondences

Taxpayer receives the following correspondences:

- Application submission acknowledgment.
- Additional information notification (only if the FTA requires more information to assist with their review of your application).
- Application conditional approval, approval or rejection notification.
- Reminder to complete the draft application (only if the applicant fails to take action on a drafted application within the regular time period).
- Draft application auto cancellation notification (only if the applicant fails to take action on a drafted application within a particular time period).
- Notification to submit the final Corporate Tax Return.
