# Introduction

This manual is prepared to help a Corporate Tax registered Taxpayer to navigate through the Federal Tax Authority EmaraTax portal and submit their Corporate Tax De-Registration application. A Taxpayer is eligible to apply to the FTA for De-registration from Corporate Tax based on the following criteria:

- Cessation of Business
- Sale of Business
- Merger of Business
- Redomiciliation of Business
- Any other reasons for Corporate Tax purposes

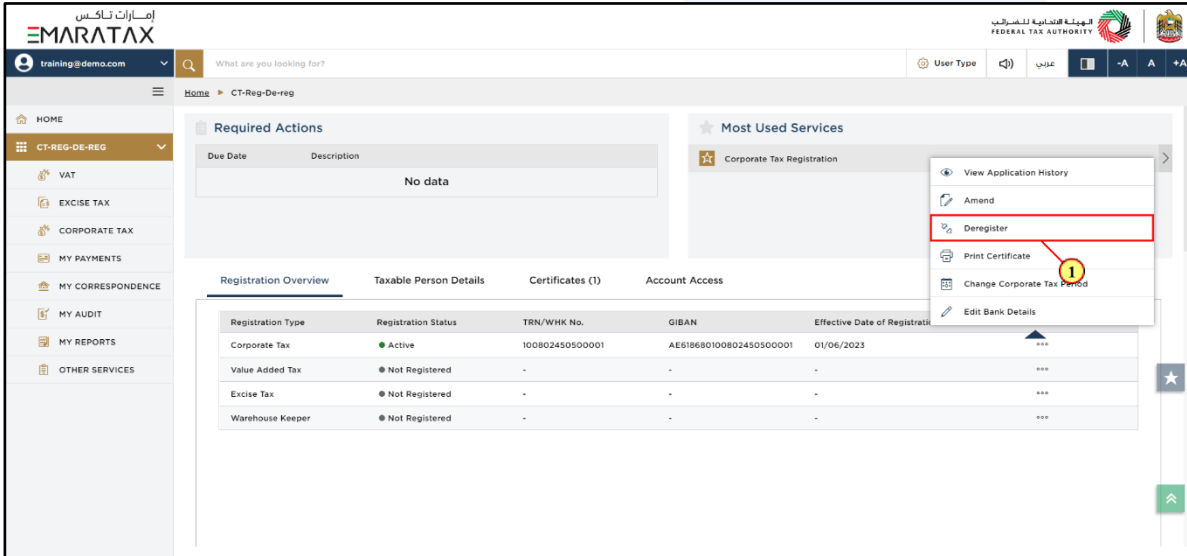

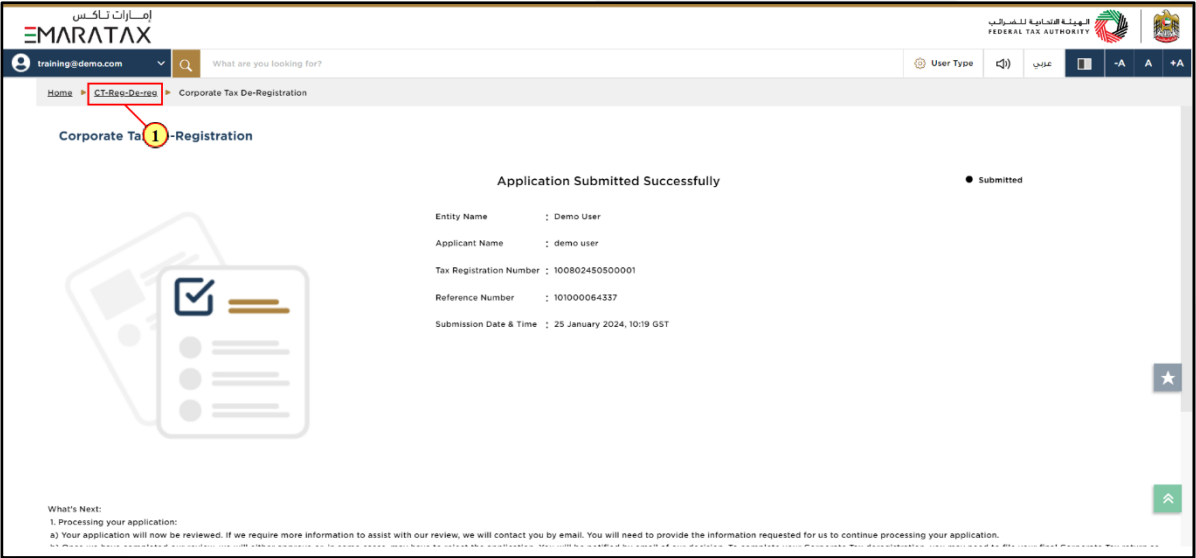

- The FTA will not proceed with the De-Registration application if the Taxpayer has other pending applications (example, Change in Tax Period application). Additionally, the De-Registration request will not be approved unless the Taxpayer has settled all outstanding tax liabilities.
- The status of your application in the dashboard will be updated accordingly. You may check your application status in the dashboard from time to time.
