Navigating through EmaraTax

The following Tabs and Buttons are available to help you navigate through this process:

Button	Description
In the Portal	
💮 User types	This is used to toggle between various personas within the user profile, such as Taxable Person, Tax Agent, Tax Agency, Legal Representative, etc
□')	This is used to enable the text to speech feature of the portal
عربي English	This is used to toggle between the English and Arabic versions of the portal
-A A +A	This is used to decrease, reset, and increase the screen resolution of the user interface of the portal
Manage Account	This is used to manage the user profile details such as the Name, Registered Email Address, Registered Mobile Number, and Password
(Log Out	This is used to log off from the portal
In the Business Process application	
Previous Step	This is used to go to the Previous section of the Input Form
Next Step	This is used to go to the Next section of the Input Form
Save as Draft	This is used to save the application as a draft, so that it can be completed later


Introduction

This manual is prepared to help a registered Juridical Person Tax Agent to navigate through the Federal Tax Authority EmaraTax portal to link a Natural Person Tax Agent. The Juridical Person Tax Agent needs to initiate a Natural Person Tax Agent link request application. The Natural Person Tax Agent needs to accept the request by logging into their Emara Tax account. Once the request is accepted, the application shall be sent to the FTA for review. On approval of the application by the FTA, the Natural Person Tax Agent shall be linked to the Juridical Person Tax Agent.





Login to EmaraTax






You can login into the EmaraTax account using your login credentials or using UAE Pass. If you do not have an EmaraTax account, you can sign-up for an account by clicking the 'Sign Up' button. If you have forgotten your password, you can use the 'Forgot password?' feature to reset your password.






Link Juridical Person Tax Agent to Natural Person Tax Agent

(1)	Click 'Manage' in the Natural Person Tax Agent Management tile.







- The application status of linking of each Natural Person Tax Agent is also available in the list.







Add Natural Person Tax Agent






To add the Natural Person Tax Agent, you can search via 'Tax Agent Number (TAAN)' or 'Emirates ID'.








Step	Action






Step	Action
(1)	Select 'Designation' from the dropdown list.





(1)	Upload the 'Copy of Letter of Appointment'.









Correspondences

Juridical Person Tax Agent receives the following correspondences:


- Application acceptance acknowledgment.
- Additional acceptance or rejection notification (after Natural Person Tax Agent accepts or rejects the link request; or an auto cancellation of the application in case Natural Person Tax Agent does not take any action).
- Additional Information notification (only if the FTA requires more information to assist with their review of your application).
- Application approval or rejection notification by the FTA.





Application History - In-Review


Once the Natural Person Tax Agent accepts the linking request, the application will be sent to the FTA for review and the status of the application will be 'In-Review'.



Step	Action
(1)	Click 'Manage' in the Natural Person Tax Agent Management tile.










You can check the status of the Linking application based on the application number once the application has been submitted.





Application History – Approved

Once the FTA approves your application, the linking process is complete between the Juridical Person Tax Agent and Natural Person Tax Agent, and Registration Certificates are issued by the FTA to Juridical Person Tax Agent and Natural Person Tax Agent.






You can check the status of the Linking application based on the Application Number once the FTA has approved the application.






Juridical Person Tax Agent Registration Certificate
