A project that offers a set of privileges such as expedited issuance of Tax Registration Number (TRN) and Tax Residency Certificate (TRC), and access to affordable tax accounting software, subject to specific conditions. These privileges will be granted to small and medium enterprises (SMEs) following their participation in specialised training programmes on tax procedure policies and their qualification in matters related to Value Added Tax (VAT) and Excise Tax, in order to support their compliance with applicable tax laws and procedures.

Issuance of Residency Tax Certificates

Residency Certificate issuance system, whereby the process will be automated, enhanced, and streamlined through automated population, real-time verification of data submitted information, and a reduction in the number of required documents. The upgraded system will also enable integration with the Federal Authority for Identity, Citizenship, Customs & Port Security to verify relevant data.

A holistic redesign and substantial transformation of the Tax



Maskan offers a unified platform (mobile application) that allows citizens to recover VAT on housing construction and enables suppliers to issue tax invoices through the application. By automating the service for the customer, Maskan reduces the burden on the applicant. Through the system, all tax invoices for expenses incurred by the citizen from suppliers are added, and records of these expenses are created to facilitate the verification process for refund purposes. The Housing Completion Certificate will be submitted through coordination with local authorities in each emirate and processed via the system, after which a refund request is automatically generated.


