




Entering to the TRC Portal

On entering the TRC Page, the system will validate whether the email logged into Emaratax is the same email as the one used previously in the old TRC platform.



Case 1 – If the email used for logging into Emaratax is different than the email used for the old TRC platform, the system will generate the below popup message. This step is important as it requires the applicant to enter their TRC email and if validated, an OTP will be sent **to the TRC email that was used in the old TRC platform**. Failure to do so will result in not being able to view previously submitted requests from the old TRC platform.



Case 2 – If the email used for logging into Emaratax is the same as the email used for the old TRC platform, the applicant will be directed to their profile.



Linking the TRC Registered Email Address

The user has an option to link a TRC Registered Email Address if the user missed to link the existing TRC email address in the initial account creation and its valid for **one time use only**.

This feature allows the user to link their account with old TRC account only and if the user tries to add an email address which is not present in the old TRC database it will restrict the user to proceed with linking to a different email address.

- **My Drafts** - To show all the draft applications initiated by the end user.
- **Payment History** - To view all the transactions made on the TRC Portal by the user.
- **User Profile** - To view and manage the applicant's details and address.

Fee Reduction

Kindly note that a reduction of the fee for the Tax Residency Certificate shall only be available to Corporate Tax Registrants applying using their Corporate Tax TRN.

A VAT TRN can be used but shall only support the completion of application, where Corporate Tax TRN is not available. A VAT TRN shall not grant a fee reduction.

To qualify for a fee reduction, the following criteria must match the information provided by Emaratax:

1. Your Corporate Tax TRN must be valid.
2. The entity name or beneficiary name entered should be exactly as entered in Emaratax Portal for verification to take place.
3. If a trade license number is provided, it must match the corresponding details related to the entered CT TRN and should be match to the information on Emaratax Portal.





Submission Fee Payment

Once the user proceeds to next step post review, the system will redirect the user to pay the initial submission amount. Once the payment is successful, a request will be registered in the TRC portal and assigned to an FTA Tax Officer.

Application Submission & Review

Once the user submits the application post the submission fee, it will be assigned to FTA officer to review and take the necessary actions for the certificate request and user will be able to get real time updates via emails and can track it from All Requests Screen. Each status represents -
