- You must present the tax invoice at the validation point when you leave the country.

- The shop assistant completes the sale and scans your passport or GCC National ID
- Your tax free transaction will be issued successfully once you've submitted your contact details to the shop assistant.
- The digital invoice will be sent to you via email by the merchant.
- The physical tax invoice is not required to be presented at the validation point

## HOW MUCH WILL YOU GET BACK?

You will receive **85%** of the total VAT amount paid, minus a fee of AED **4.80** per **Tax Free Tag.**

Using Planet Shopper Portal is the easiest way to track your UAE tax free transactions while you are on the go.

#### Steps are as follows:

- After your purchase is complete you will receive a link via sms
- Click on the link to the Shopper Portal to access all the features available at your disposal

### WHO IS ELIGIBLE?

"Overseas tourist" means any Natural Person whose age is 18 years old or above, is not a resident in any of the Implementing States and who is not a crew member on a flight or on an aircraft or cruise ship leaving an implementing State.

### WHAT IS TAX FREE SHOPPING?

Tax Free shopping is the purchasing of certain taxable goods in the UAE which will be exported (subject to terms and conditions) whereby shoppers can obtain a refund of the VAT charged on these goods provided that they validate their purchases at the point of exit.

Refunds for already export validated tags can be claimed within one year from the date of export validation.

## GUIDE TO TAX FREE SHOPPING

### WHAT GOODS ARE ELIGIBLE FOR TAX FREE SHOPPING?

#### Certain taxable goods except for:

- Goods that have been consumed, fully or partially, in the UAE
- Motor vehicles, boats and aircrafts
- Goods that are not accompanied by the overseas tourist at the time of leaving the UAE

### HOW DO YOU SHOP TAX FREE?

### 100% DIGITAL 250 DIRHAMS MINIMUM SPEND

- The tourist makes an eligible purchase.
- The shop assistant captures information from the tourist's passport or GCC National ID card using the solution (this should be the same Passport or GCC National ID that was used to enter the UAE).
- The shop assistant enters the transaction purchase details (sales amount, VAT amount and date of purchase).
- The Tax Free Tag is attached to the back of the tax invoice.
- The Tax Free Tag is scanned to link the transaction with the tourist's Passport or GCC National ID card.

Please retain the Tax Free tag and tax invoice as you will need this for validation when you leave UAE.

### HOW DO YOU VALIDATE YOUR TAX FREE PURCHASES?

- Before you check in your luggage, take the goods and tagged tax invoice to one of our validation points.
- If you are using the self-service kiosks, kindly scan your passport or enter your passport / national ID number manually. If you will be going to the manned validation desks, please provide your passport / national identity card to Planet staff.
- S Follow the instructions on screen if you are using a self service kiosk, and if you get a green light, you've completed the validation process.
- If you get a red light, contact one of our Planet staff who are standing next to the validation point for help.
- 5 Once you have completed the validation process, please choose your preferred refund method credit/debit card, cash or through WeChat application.
- blanet Tax Free will process your refund request.

\* If choosing a cash refund, the maximum refund amount is AED 35,000 per tourist. If your refund amount exceeds AED 35,000/-, you will have to provide us with a valid credit/debit card to enable us to process your refund.

### HOW MUCH TIME DO YOU HAVE TO COMPLETE THE PROCEDURE?

You must export your goods from the UAE within 90 days from the date of supply / purchase of goods (captured in the sales tax invoice). For example, if your date of purchase is the 1<sup>st</sup> of April, you must export your goods before the 30<sup>th</sup> June to claim your refund. Failure to meet this requirement of exporting goods within 90 days will result in shoppers foregoing their refund on such purchases.

### THE MERCHANT ISSUING THE HANDWRITTEN TAX INVOICE:

Some retailers in the UAE still use handwritten tax invoice when you shop with them and we wanted to make sure you could still benefit from tax-free shopping with Planet.

Here is what you need to know about this type of refund:

- A sales representative enters your details in our system using your passport/ GCC ID
- The sales representative then inputs the total sales value, VAT amount, and invoice number
- They will then scan the QR code on the physical tax-free tag and place it on the back of your tax invoice
- The representative will then take a photo of your tax invoice and upload it to our system.
- 5 Our Quality Control team will verify the photo in real-time.
- If the verification is denied, you must present the tax invoice at the validation point when you leave the country.
